# COMMON COUNCIL OFFICIAL JOURNAL

The Common Council of the City of Manitowoc, Wisconsin, met in regular session at the Council Chambers in City Hall, on Monday, January 20, 2014. Said meeting was duly called, noticed, held and conducted in the manner required by the Common Council and the pertinent Wisconsin Statutes.

Mayor Justin M. Nickels called the meeting to order at 7:00 p.m. and on roll call the following members were present: Alderpersons Dave Soeldner, Jim Brey, Alan Schema, Mike Howe, Christopher Able, Jason Sladky, Scott McMeans, Tyler Martell and Jill Hennessey.

Absent: Alderperson Eric Sitkiewitz.

Pledge of Allegiance.

Invocation.

City Clerk announced that the various documents have been referred to the appropriate committees as shown on the January 20, 2014 Common Council agenda.

Attorney Greg Gunta presented update on Swetlik v. Crawford, et al lawsuit.

Rolf Johnson, the new Executive Director of the Wisconsin Maritime Museum, introduced himself.

Mayor declared the meeting open for a public hearing for the purpose of hearing any and all interested parties in the matter of proposed change in zone from "R-1" Residential-Agricultural and "R-6" Multiple Family District to "B-2" Neighborhood Business District, in an area located west of South Alverno Rd., east of Wimmer Rd. and north and south of Calumet Ave. (USH 151).

City Clerk reported that the notice of the hearing was published in the Herald-Times-Reporter on January 9 & 13, 2014. (Proof of publication is on file in the City Clerk's office).

City Planner David Less gave an overview of the proposed zone change.

No interested parties appeared.

Mayor declared the public hearing closed. (A recording of the entire hearing is on file in the City Clerk's office).

Mayor declared the meeting open for a public hearing for the purpose of hearing any and all interested parties in the matter of proposed change in zone from "I-2" Heavy Industrial District to "B-2" Neighborhood Business District, in an area located north of Franklin St., south of Wisconsin Central Railroad tracks, west of S. 24<sup>th</sup> St. and east of S. 26<sup>th</sup> St.

City Clerk reported that the notice of the hearing was published in the Herald-Times-Reporter on January 9 & 13, 2014. (Proof of publication is on file in the City Clerk's office).

City Planner David Less gave an overview of the proposed zone change.

Bob Lemke, member of Wisconsin Redevelopment, LLC, of Wauwatosa, WI appeared to address the Council regarding the change in zone.

No other interested parties appeared.

Mayor declared the public hearing closed. (A recording of the entire hearing is on file in the City Clerk's office).

Mayor declared the meeting open for public input. In accordance with policy, the public input portion of the meeting is not made a part of the official record.

Prior to going into recess, Mayor publicly announced that during the recess the standing committees of the Common Council, as well as the Committee of the Whole, will meet in the Common Council Chambers to discuss and act upon some of the matters which have been discussed or referred at this Common Council meeting.

Recess.

During recess, Committee of the Whole held a short discussion relative to resolution (14-013) increasing the Police Chief's salary from a Classification 22, Step 9 of the Performance Based Compensation Schedule, with an hourly rate of \$43.78 to an hourly rate of \$46.19 per hour effective immediately and \$48.59 per hour effective January 1, 2015. It was moved by Sladky, second by Martell, to table the resolution. Ayes, 8. Nays, 1. Motion carried.

During recess, Public Safety Committee held a discussion relative to resolution (14-042) implementing vehicular accident spill cleanup fees. Moved by McMeans, second by Martell, to adopt the resolution. Moved by Martell, second by McMeans, and unanimously carried to amend the resolution as follows: Change item (1), small spill cleanup from \$25.00 to \$67.50; change item (5) from \$25.00/bag to cost; change item (6) from \$12.50/bag to cost; and to eliminate lines (2) and (4). Ayes, 4. Nays, none.

Call back to order.

Motion by Sladky, second by Schema, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Parks and Recreation Committee returned contract (14-016) with Franz Electric for removing existing main lug service panel and providing and installing a new Type 3R main breaker panel at the Lincoln Park Zoo at a cost of \$4,821.00, recommending awarding contract to Franz Electric/Denor Electric. Motion by Sladky, second by Schema, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Motion by Able, second by Hennessey, to accept the Committee's report (adopt the resolution). Ayes, 5. Nays, 4. Motion failed for lack of approval by a 2/3 vote of the Common Council pursuant to Resolution 13-344 adopted July 1, 2013.

Personnel Committee returned resolution (14-025) to increase the Rahr-West Art Museum's Curator position from a part-time seasonal position to a full-time position at the rate of \$16.75 per hour effective upon approval by the Common Council, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Personnel Committee returned resolution (14-026) to approve the hiring of a part-time Transit Driver at the rate specified in the Transit Teamsters Collective Bargaining Agreement, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Personnel Committee returned resolution (14-027) to fill the position of City Attorney in accordance with the Mayor's 2014 Budget, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Personnel Committee returned resolution (14-028) to approve amendment to the Services agreement with BMO Harris Bank, N.A. naming privacy contacts relative to the Flexible Benefits Plan, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Personnel Committee returned resolution (14-029) to approve revised job descriptions within the Rahr-West Art Museum, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Personnel Committee returned resolution (14-030) to approve revised job descriptions within the Recreation Department, recommending approval of the resolution. Motion by Able, second by Hennessey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Public Infrastructure Committee returned ordinance (14-011) to adjust rates for sewer service charges established in Municipal Code Section 25.050(8) effective January 1, 2014, recommending adoption. Motion by Soeldner, second by Brey, and unanimously carried to suspend the rules to take immediate action on this ordinance. Ayes, 9. Nays, none. Motion by Soeldner, second by Brey, report accepted and ordinance adopted. Ayes, 9. Nays, none.

Public Infrastructure Committee returned resolution (14-014) to advertise for bids covering installation of new sidewalks and repair or replacement of defective or insufficient sidewalks for 2014, with the expense to be assessed pursuant to Section 66.0907 of the Wis. Stat., recommending adoption. Motion by Soeldner, second by Brey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Public Infrastructure Committee returned resolution (14-015) to place dust palliatives on the streets listed in 2014 and assessments be made against the abutting property owners, recommending adoption. Motion by Soeldner, second by Brey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Public Infrastructure Committee returned resolution (14-017) to place listed streets in 2014 Seal Coating Program and assess the abutting property owners pursuant to Section 7.320 of the Municipal Code, recommending adoption. Motion by Soeldner, second by Brey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Motion by Soeldner, second by Brey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Public Infrastructure Committee returned special events request (14-032) from Kathie Bundy, Parade Coordinator, to hold the 16th annual St. Patrick's Day parade on March 14, 2014 with fireworks to follow,

recommending approval subject to City policy. Motion by Soeldner, second by Brey, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.

Public Safety Committee returned resolution (14-042) implementing vehicular accident spill cleanup fees, recommending adoption, as amended. Motion by Martell, second by Schema, and carried by acclamation to accept the Committee's report. Ayes, 8. Nays, 1.

Motion by Martell, second by Schema, and unanimously carried to accept the Committee's report. Ayes, 9. Nays, none.
