Old Business

 Statement by Hennessey that the City would cover the cost of the museum addition study was clarified to explain that the funds would be taken from the Rahr-West Art Museum Restricted funds designated for this type of expense.

Presidents Report – Amy Fricke-Weigel

- 1. Website
 - a. Website committee met on February 4th with CivicPlus.
 - b. The RWAM Website is scheduled to go live effective July 1, 2011.
 - c. Individuals will be able to register for classes and membership online
 - 1. Will be able to use their credit card
 - 1. Fees will be the responsibility of the individual making the charge

2. Personnel

- a. Fricke-Weigel's February 14th meeting with the Manitowoc Personnel Committee has been pushed back to a tentative date of March 14th. Sitkiewitz and Gadzinski will also attend.
- b. One of the topics of discussion will be the vacant Director position. The board feels strongly that the Director position needs to be filled and this individual should have a background in business management as well as art.
- 3. Rally in the Alley No Report
- 4. September Exhibit
 - a. The Manitowoc Police Dept and the Manitowoc Fire Dept will be holding an exhibition in the John West Gallery to coincide with the 10th anniversary of 9/11, which will include a memorial service on September 11th.
 - b. A committee consisting of Fricke-Weigel, Kirby, Fire Chief Manis, Police Chief Dick and RWAM staff will meet on Tuesday, February 22 to begin the planning process.
- 5. Sputnikfest
 - a. This year's festival will be held on Saturday, Sept 10th, and will be a one day affair.
 - b. The tent will be left up an additional day to accommodate the 9/11 memorial service.
- 6. Education Classes
 - a. Lego Class A Lego class is scheduled to be held the week of June 27th.
 - -The classes will be 3 hours long and will be held Mon-Thurs.
 - A morning class for 1st 3rd grade & an afternoon class for 4th 8th grade each day.
 - Hennessey is checking into a possible grant to cover the museum's expense.
