This notice is given pursuant to the requirements of Sections 19.86 and 111.70, Wisconsin Statutes.

As of the date of this notice, the subject matter known to be intended for consideration at the meeting is as follows:

1. Call meeting to order
2. Initial proposal exchange for a successor labor agreement.

Convene in Closed Session

3. Negotiations for a successor labor agreement relative to wages.

Notice is hereby given that the above may adjourn into a closed session during the meeting as authorized by Section 19.85(1)(e) of the Wisconsin Statutes, which authorizes the governmental body to convene in closed session for the purpose of deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session, and, Section 111.70 of the Wisconsin Statutes which authorizes the governmental body to convene in closed session for the purpose of collective bargaining.

The specific subject matter to be considered in closed session is number 3 noted above.

Reconvene in Open Session

4. Adjourn.
