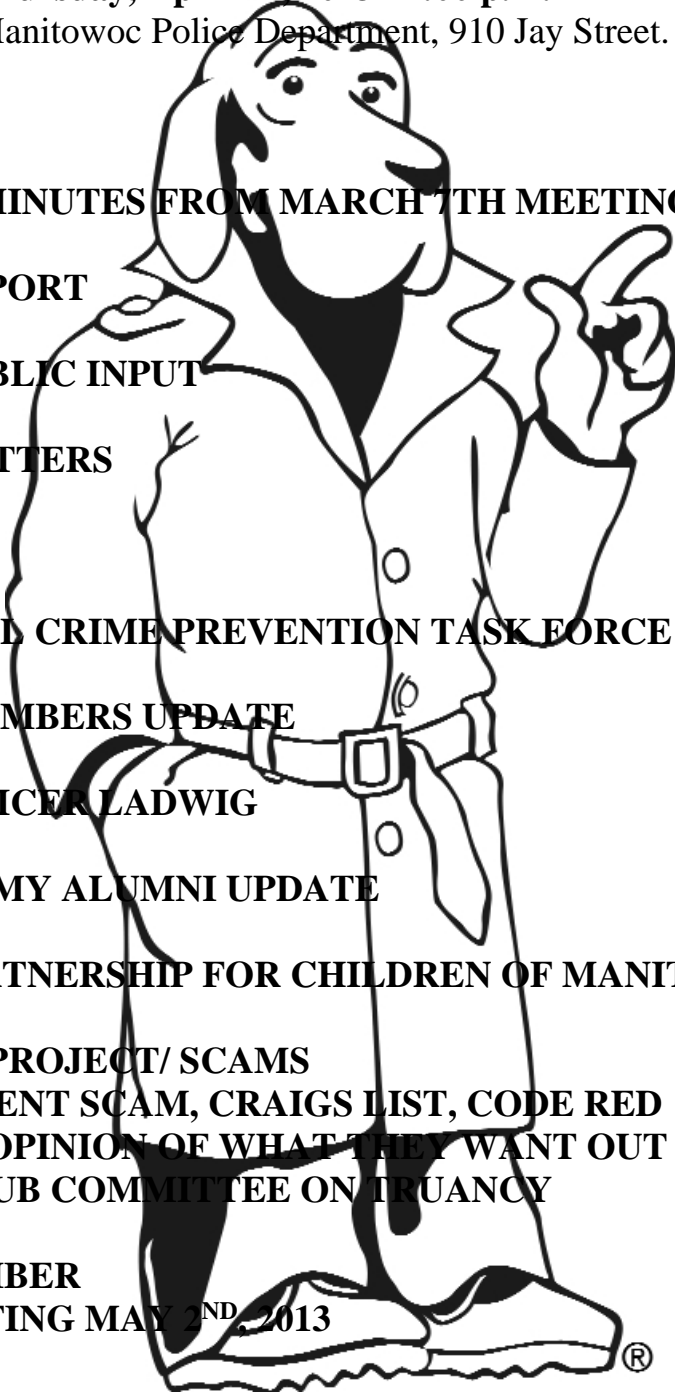

- 2) Review of CPC Minutes from December Meeting- Changed date to February 14<sup>th</sup>. Meeting was postponed due to weather. Motion Moved to accept by Jay Skinner and Seconded by Kellie Becker
- 3) Treasurer's Report- Hand out given to committee by Mary Schilder and approved by Jay Skinner and seconded by Ralph Kramer.
