Meeting Minutes

Board of Review

Tuesday, June 5, 2018 5:30 PM Common Council Chambers

Call to Order

The Board of Review was called to order at 5:30 p.m. with public notice given in accordance with Wisconsin Statues.

A resolution was adopted by the Common Council on October 6, 1980, providing that the Board of Review shall meet in Council Chambers or in such other room in City Hall that may be available, providing that notice of the meeting in such room is posted on the door to the Council Chambers prior to the meeting.

An ordinance was adopted by the Common Council on May 16, 1994, and published on May 18, 1994, to reduce the size of the Board of Review from eight members to seven members, thereby reducing a quorum from five to four members.

An ordinance was adopted by the Common Council on May 15, 1995, providing that the Board shall be composed of the Mayor, City Clerk and five members of the Common Council to be appointed by the Mayor. The Mayor may appoint up to five additional members of the Common Council as alternates to serve in the event of the unavailability of any member.
