Tree near 5012 Cypress Court and Drainage Issue

Leon Levenhagen, 5055 Brookfield Circle was present and informed the Committee that he wishes to keep the willow tree. He said that 5012 Cypress Court had the storm sewer drain installed to remove standing water and had cleaned this past summer. Since then there hasn't been an issue with standing water.

He has had the willow tree trimmed and believes that if the tree was not there, there would be a greater water problem. He does not want to cut the tree down until an honest appraisal of the situation is done.

D. Orth, 5012 Cypress Court, informed the Committee that since he's had his storm sewer cleaned out it is working fine, they pulled out 12 feet of root. It isn't fair that the majority of this tree is on his property and he is required to pay for this sewer to be cleaned as it is filled with the tree roots. The tree roots are pushing the drain up. D. Orth believes it is restricting the water.

Ken Sitkiewitz, explained that his sump pump runs continuously and if the water was re-routed there wouldn't be an issue.

The Committee discussed and believed this to be more of a civil matter and not something the City should be involved with.

Jeff Roberts, 5104 Edgewood Lane was present and has lived there over 30 years and has been affected by standing water coming within feet of his house. He said that he and Don Orth are most affected by the water.

E. Sitkiewitz reported that this area is meant to drain and it's not draining. There shouldn't be anything in the drainage easement.

Ruby Orth expressed that her concern is that the sewer will become blocked up again with tree roots and this will be an ongoing process. The majority of the tree is on their property and they would like to see removed.

D. Koski said that they met with City Attorneys after they received the letter from Mr. Levenhagen. They can't say that the tree is the cause of this flooding.

Lee Kummer said the next step would be to get an estimate and bring back for discussion next month.
