RESOLUTION ESTABLISHING FIRE/RESCUE RATES FOR 2018


WHEREAS, the Mayor and Common Council desire to provide emergency medical service at a reasonable rate which will help cover the expense of the paramedic response program as much as possible; and

WHEREAS, the Public Safety Committee approved the attached rate changes at their meeting on November 13, 2017.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council that effective January 1, 2018, the charges for transportation and care by the Fire Rescue Department shall be as follows:

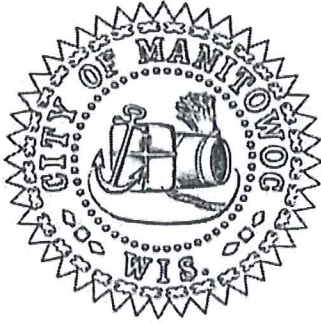
